

CANACCORD GENUITY GROUP INC. DISCLOSES TRANSACTION IN OWN SHARES UNDER NORMAL COURSE ISSUER BID/BUY-BACK PROGRAMME

TORONTO, December 8, 2015 – Canaccord Genuity Group Inc. (the "Company") (TSX: CF, LSE: CF.) wishes to announce that for the period of December 1 to 7, 2015, it purchased 25,000 of its common shares through the facilities of the TSX and alternative trading systems pursuant to the normal course issuer bid (NCIB)/buy-back programme announced on August 10, 2015.

The highest and lowest daily average price paid for the purchased shares was \$4.7620 and \$4.6640 per common share respectively and the volume weighted average price per common share was \$4.7162.

The Company has purchased 467,367 common shares under the NCIB/buy-back programme which authorizes it to purchase up to 5,163,736 of its common shares between August 13, 2015 and August 12, 2016. Of these shares, 427,667 have been cancelled and the remaining 39,700 shares will be held in treasury until they are cancelled within the next 60 days.
