The highest and lowest daily average price paid for the purchased shares was \$6.7851 and \$6.6094 per common share respectively and the volume weighted average price per common share was \$6.6865.

The Company has so far purchased 1,649,992 common shares under the NCIB which authorizes it to purchase up to 5,136,948 of its common shares between August 13, 2013 and August 12, 2014. Of these shares, 1,210,036 have been cancelled and the remaining 439,956 will be held in treasury until they are cancelled within the next 60 days.
