These shares were acquired for cancellation under the normal course issuer bid (NCIB)/buy-back programme which authorizes it to purchase up to 5,136,948 of its common shares between August 13, 2013 and August 12, 2014. To April 30, 2014, the Company has acquired 2,634,304 common shares under this programme.

For the purposes of the Financial Conduct Authority's Disclosure and Transparency Rules, as at April 30, 2014, the total number of common shares in issue was 101,230,783 with each share carrying the right to one vote. This total may be used by shareholders in the Company as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change in their interest in, the share capital of the Company under the FCA's Disclosure and Transparency Rules.
