Annual General Meeting of Shareholders held on August 2, 2018

TORONTO, August 2, 2018 - Canaccord Genuity Group Inc. (the "Company") (TSX:CF) today announced (in accordance with Toronto Stock Exchange requirements) the voting results from its annual general meeting of common shareholders held on Thursday, August 2, 2018. Full details of these matters are set out in the Management Information Circular issued in connection with this meeting, which is available at www.canaccordgenuitygroup.com. Shareholders voted in favour of the appointment of Ernst & Young LLP as auditors of the Company for the ensuing year and authorizing the directors to fix their remuneration (99.60% in favour), in favour of the ordinary resolution which, among other things, approved the Performance Stock Options (PSO) plan and ratified awards made under that plan (91.68% in favour) and in favour of setting the number of directors at eight (99.84% in favour) and voted on the election as directors of nominees proposed by management as follows:
